5. GENERAL ISSUES

a. Hiring Journal

Cianni reported Doug Harrington had accepted the Street Maintenance Operator position and will begin employment on May 23rd. Cianni stated Scott Harrington had been promoted to the Solid Waste Operator position through an internal hire and the City is now looking to fill a Solid Waste Laborer position. Cianni stated interviews had been conducted for the IT Coordinator position and Aaron Meyer started with the City today.

b. Roster Approval – Code Enforcement Officer

Cianni stated four applications were received for the position and because there were seven or less applications no point scoring was completed.

City Administrator Shawn Kessel asked that Public Works Director be added in Essential Duty number 12 as the position is City Engineer/Public Works Director.

Glen Roshau questioned what considerable knowledge meant in several of the points in the "Knowledge, Skills and Abilities" section. It was decided to remove the word considerable in each of these points.

The Commission questioned the three years of experience required and whether or not an individual right out of school would be considered for the position. City Engineer Soehren indicated they would not. The Commission voiced concerns with being able to fill the position. Soehren indicated in this position he will need someone with experience based on the duties and the need for the individual to act as the City Engineer from time to time.
