- The Dickinson Police Department may ask a registrant to check their recordings for a specific date and time should officers determine the potential for video evidence in the vicinity of the registrant's surveillance system.
- Any footage containing or related to criminal activity may be collected by the Dickinson Police Department for use as evidence during any stage of a criminal proceeding.
- Under no circumstances will registrants construe they are acting as an agent or employee of the City of Dickinson or the Dickinson Police Department.
- Under no circumstances will the Dickinson Police Department utilize any information obtained to access or view live recordings or feeds coming directly from cameras owned by registrants.
- If you wish to withdraw from the program, please contact the Dickinson Police Department Community Resources Officer, Sergeant Brandon Stockie, at your earliest convenience to opt out.
